SUSTAIN AND PRIORITIZE EFFECTIVE DISPUTE RESOLUTION, EQUITY, AND ACCESS TO JUSTICE EFFORTS

Washington's 21 Dispute Resolution Centers (DRCs) strengthen equity in dispute resolution through free or affordable community-based mediation and training statewide, including trauma-informed services supporting housing stability, family stability, and youth and community restorative practices.

- DRCs help families, individuals, organizations and communities to effectively navigate conflicts amid mounting economic, political, and social pressures.
- DRCs provide community access to justice in response to tensions including polarization, housing crises, family struggles and public safety.



- DRCs meet clients where they are, and meet accessibility needs through language assistance, options for in person, phone, and online services, working with community partners.
- The DRCs continue to deliver voluntary housing stability services following the June 2023 conclusion of the two-year, mandatory Eviction Resolution Pilot Program, in addition to other dispute resolution and training services.
